F. The Case of Teaching Assistants:

As per norms, Teaching Assistant cannot be treated as regular faculty especially when there is a shortage of in-house accommodation. It has also been noted by the August House on 31.08.2017 under the Convenership of Prof. Sanket Vij, former Convener HAC; the same is also noted by all the members of the present H.A.C.

That the earlier allotment of Type-III Houses (top floor) is being availed solo or double by the Teaching Assistants, whereas the permanent faculty (both Teaching & Non-Teaching) is facing shortage of houses.

Decision:

It is unanimously recommended that all Teaching Assistants/Guest teachers be lodged in the New Hostel No. 15. The General Branch must ensure that these top floor of the quarters be got vacated within 30 days.

The compliance be reported by the General Branch to the H.A.C.


N.B: (1) There is no more vacant/inhabitable accommodation in the above category of quarters except type III. Hence, the committee is not able to consider the leftover applications.


(2) All the cases have been disposed as of date. Therefore, new applications be called for the next H.A.C. on the prescribed format.


